NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Maroa, Macon County, Illinois, as follows:


SECTION 1. The following shall be added to § 184-1 Specific Nuisances Enumerated:

W. Storm Damage Debris. To allow storm damage debris of any kind to collect and/or remain upon a property for a period more than 30 days.




