**AN ORDINANCE ESTABLISHING AUTHORIZED AGENT STATUS FOR

**WHEREAS** IMRF requires Council designation of its authorized account agent;

**WHEREAS** the City Clerk is the authorized agent for all City payroll related accounts;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Maroa, Macon County, Illinois, as follows:

**SECTION 1.** The authorized agent for the City IMRF account shall be the seated City Clerk.


**SECTION 2.** Official notice to IMRF of current City Clerk shall be in the form of City letterhead, specifying the name of seated City Clerk and signed by the City Administrator.

**SECTION 3.** Agent authorization can be revoked, as allowed by law, by order of the Mayor and City Council.


