AN ORDINANCE ESTABLISHING DEPARTMENT AUTHORIZATION FOR CREDIT CARDS.

WHEREAS Scott State Bank requires written authorization for City credit card holders;

WHEREAS the City Clerk and City Administrator, Chief of Police and Superintendent of Public Works are generally the primary purchasers for the City of Maroa;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Maroa, Macon County, Illinois, as follows:

SECTION 1. The individuals elected or appointed to the positions of City Administrator, City Clerk, Chief of Police and Superintendent of Public Works shall, upon taking the oath of office, immediately become official authorized credit card holders for the City of Maroa.

SECTION 2. Associated monthly limits for each credit card shall be \$5,000.00.

SECTION 3. Credit card authorization can be revoked for any position, as allowed by law, by order of the Mayor and City Council.
