## AN ORDINANCE AMENDING MAROA CITY CODE OF ORDINANCES § 18-2 REGULAR MEETINGS.

**WHEREAS** by City Ordinance, regular City Council meetings are required to be held on a predetermined day under normal circumstances;

WHEREAS the appropriateness of this day is to be considered occasionally by the City Council;

**WHEREAS** in the event this day is found to conflict on a regular basis with other City obligations, official's schedules or other reasons, the City Council has the authority to change the regular meeting date by ordinance;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Maroa, Macon County, Illinois, as follows:

**SECTION 1.** Section § 18-2 **Regular meetings** of the Maroa City Code of Ordinances is hereby amended as follows:

#### § 18-2 Regular meetings.

[Amended at time of adoption of Code (see Ch. 1, General Provisions, Art. I)]

The regular stated meetings of the City Council shall be held in the City Hall Building on the fourth first Monday in each month at a time set by the City Council. When said meeting date falls upon a legal holiday, the meeting shall be held on an alternate day the next secular day at the same hour as designated by the City Council. Adjourned meetings may be held at such times as may be determined by the Council. Public notice of regular meetings shall be given in accordance with the Open Meetings Act, 5 ILCS 120/1 et seq.
