

AN ORDINANCE AMENDING THE REVISED CODE OF ORDINANCES OF THE CITY OF MAROA, MACON COUNTY, ILLINOIS SPECIFICALLY CHAPTER 38, ARTICLE II, SECTION 16, WATER RATES AND ARTICLE V, SECTION 72, SEWER RATES.

WHEREAS the City of Maroa has determined that it is in the interest of the public health and safety to modify its Ordinances dealing with Water and Sewer rates:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Maroa, Macon County, Illinois, as follows:

SECTION 1. The Revised Code is amended as follows with language being added to the Code, if any, shown underlined, language being removed from the Code, if any, being stricken through and/or being repealed by reference to a chapter, article or section and language remaining unchanged in the Code, if any, being neither underlined nor stricken through and language contained in brackets [], if any, being explanatory notes, which may effect the interpretation of the language of the Code, but language in brackets, itself, not being added to the Code:

38-2-16 WATER RATES. The following rates for the use and service supplied by the Waterworks System shall be based upon the amount of water consumed as follows:

(A) RESIDENTIAL – “INSIDE CORPORATE LIMITS”

First 1,000 gallons ~~6.56~~ 6.89 MINIMUM RATE PER MONTH

Over 1,000 gallons ~~5.84~~ 6.10 Per 1,000 Gallons per month

38-5-72 BASIC USER RATE. [Sewer.] There shall be and there is hereby established a minimum charge and basic user rate for the use of and for service supplied by the City Wastewater facilities.

(A) A minimum charge of ~~Six Dollars Fifty Six Cents (6.56)~~ Six Dollars and Eighty Nine Cents (6.89) per month shall be applied to all users whose water consumption does not exceed one thousand gallons (1,000) per month.

(B) A basic user rate shall be applied to all users for water consumption in excess of one thousand (1,000) gallons per month in the amount ~~Two Dollars Seventy Three Cents (\$2.73)~~ Two Dollars Eighty Seven Cents (2.87) per one thousand (1,000) gallons.


This ordinance is effective with the September 2016 bills.


