### **POLICE REPORT:**

- The Chevy Tahoe that was retired sold at the auction for \$6,750.00 (minus 5%).
- The Police Department had two aggravated kidnappings.
- The Police Department now has all the new vehicles in-house and in the fleet. There are a few minor matters with the truck to be completed by Federal Signal.
- Administrator Agee and Chief Fitzgerald were able to complete the task of having all the City's ordinances put into an Excel format early. It has been provided to Digi-Ticket and CIRDC.
- Administrator Agee and Chief Fitzgerald have begun beta testing the new City ordinance warning/violation form that can be used across all departments. After some minor adjustments, they plan to have it 100% in-use. This update will be a considerable time-saver and make issuing warnings and OV's much easier for all departments. It will also assist violators in understanding how to remedy the violation.
