### NEW BUSINESS:

- Mayor Wilkey noted the Park Committee met last Tuesday. Committee members came up with some ideas for improvements to Spencer Park, Young Park and the City Hall gym. Administrator Agee has put together multiple estimates and emailed them to the Council for review before the meeting.

### CITY HALL REPAIRS / IMPROVEMENTS:

- Administrator Agee is looking into options for upgrading the gym floor.

### SPENCER PARK REPAIRS / IMPROVEMENTS:

- Administrator Agee purchased portable pickle ball nets for use at Spencer Park while we are awaiting final approval on permanent upgrades. We will be invoiced a total of \$960.00 for the nets. Once permanent improvements are made, the portable nets will be available for use in the gym.

- The plan is to repurpose the joint tennis and basketball court and put in three pickle ball courts. The estimate is \$43,000.00. The existing east fence is failing and will need to be replaced. The fence will be extended to encompass the entire court. Fence replacement is estimated to be \$12,000.
- The next phase would involve putting up a new basketball court next year.

**YOUNG PARK REPAIRS / IMPROVEMENTS:**

- Administrator Agee is getting estimates to put a partial basketball court up at Young Park.

**IMPROVEMENTS AT SPENCER PARK:**

- Motion by Alderperson West to proceed with Spencer Park upgrades for the three pickleball courts, not exceed \$45,000.00 and utilizing TIF and/or Business District funds where applicable.
- Second by Alderperson Bogle.
- **MOTION TO PROCEED WITH SPENCER PARK UPGRADES FOR THREE PICKLEBALL COURTS, NOT TO NOT EXCEED \$45,000.00 AND UTILIZING TIF AND BUSINESS DISTRICT FUNDS WHERE APPLICABLE.**
