# AN ORDINANCE ESTABLISHING WATER, SEWER AND METER FEE RATES AND AMENDING § 242 OF THE CITY OF MAROA CODE OF ORDINANCES.

WHEREAS by City Ordinance § 242-18 Water rates, the rates for the use and service supplied by the waterworks system shall be set from time to time by the City Council;

WHEREAS by City Ordinance § 242-80 Basic user rate, There shall be and the City Council shall establish from time to time a minimum charge and basic user rate for the use of and for service supplied by the City wastewater facilities;

WHEREAS the costs associated with water and sewer production and handling have increased significantly on an annual basis;

**WHEREAS** the City of Maroa has determined it is in the interest of the budgetary responsibility to modify its Ordinances dealing with water and sewer rates;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Maroa, Macon County, Illinois, as follows:

# SECTION 1. § 242-18 Water rates (D) is hereby added as follows:

**D.** Unless alternately increased or decreased by a majority vote of the City Council prior to May 1<sup>st</sup> of each year following passage of this ordinance, water and sewer rates shall automatically increase in the month of May by the **greater** of either of the following:

1. The 12 month AVERAGE inflation rate of the preceding calendar year, calculated by using CPI data obtained from the U.S. Bureau of Labor Statistics, or

2.5%.

**SECTION 2.** Following passage of this ordinance, for the current fiscal year, the in-town customer rate for water shall be \$7.63 for the first 1,000 gallons of usage and \$0.763 per 100 gallons of usage thereafter.

**SECTION 3.** Following passage of this ordinance, for the current fiscal year, the in-town customer rate for sewerage shall be \$7.63 for the first 1,000 gallons of metered water usage and \$0.763 per 100 gallons of metered water usage thereafter.

**SECTION 4.** Following passage of this ordinance, for the current fiscal year, the out-of-town customer rate for water shall be \$9.92 for the first 1,000 gallons of usage and \$0.992 per 100 gallons of usage thereafter.

**SECTION 5.** Following passage of this ordinance, for the current fiscal year, the rate for bulk water sales shall be \$10.00 per 1,000 gallons.

**SECTION 6.** Following passage of this ordinance, the monthly Utility Rehabilitation Fund fee shall remain \$10.00 per account until amended by a majority vote of the City Council.

**SECTION 7.** Following passage of this ordinance and beginning with the 2024-2025 fiscal year, the rate schedule for the monthly Water Meter Fund fee applied to each water account shall be as follows:

3/4" \$4.00 per month
1" \$5.00 per month
1½" \$10.00 per month
2" \$12.00 per month
3" \$15.00 per month
4" \$25.00 per month
