AN ORDINANCE MODIFYING ARTICLE VIII LOW-SPEED VEHICLES OF THE CITY OF MAROA CODE OF ORDINANCES. SPECIFICALLY ADDING § 250-8 SPECIFIC NON-CONFORMING VEHICLES ALLOWED.

WHEREAS Article VIII of the City of Maroa Code of Ordinances sets forth the restrictions regarding Low-Speed Vehicle operations on City streets.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Maroa, Macon County, Illinois, as follows:

SECTION 1. The following language shall be added to Article VIII:

§ 250-33 SPECIFIC NON-CONFORMING VEHICLES ALLOWED.

Although the following vehicles are capable of operating above Low-Speed Vehicle speeds as defined by § 250-26 Definitions, they shall be hereafter permitted on city streets with the obtaining of a Car Wash Permit at a cost of \$25. Said permit will allow the operation of these vehicles on city streets only to travel to and from the local car wash. The hours of permitted usage are from 6:00am-9:00am on Saturdays and Sundays. The vehicles must also conform to all other restrictions and requirements of Article VIII.


