POLICE BOARD MEETING NOVEMBER 14, 2017 MINUTES

The Police Board Meeting started @ 6pm with Chairman Jason Edwards, & Alderman Erick Peart present. Attending was Chief Scott Gaddy, Officer Jonathan Layendecker, Officer Aaron Koonce, Officer Stephen Pringle & Officer Chad Hickey.

Dash Camera Systems:

Chief Gaddy explained that One (1) CopTrax Dash Camera had been returned to save cost this year, due to CopTrax requires a Server for Software Operating. The Chief received three (3) bids: Lloyd It Services for \$3439.00 w/\$100.00 Monthly Service Plan Per Computer, Decatur Computer Inc. for \$6316.74 w/\$249.00 Service Plan, but did not say if that's a Monthly or Yearly & Striglos Everything Office for \$13516.00. The PD saved \$5500.00 by sending Unit back to Stalker Radar with that fee already Budgeted to help pay for the Server needed.

Discussion was Striglos bid was out and looking at Decatur Computer Inc. do to they were local company. Chief agreed to look into the \$249.00 Service Plan Fee for Monthly or Yearly.

Macon Co. Sheriff Department Squad Car:

Ald. Peart had talked with Lt. Butts over last week about the Squad being delivered to Maroa PD. Ald. Peart was told squad would be delivered Monday (11/13) or Tuesday (11/14), but as of the meeting No squad. Ald. Peart agreed to make phone call later that week to find out why squad was not delivered.

Dispatch Fee:

Chief Gaddy explained after meeting with DeWitt Co. Tony Harris (Dispatch Coord.) & DeWitt Co. Manager on November 9th, that PD would be best to stay with Central Illinois Regional Dispatch Center this year for the cost of \$26410.27.

DeWitt Co. only charges the Police Department in the county with DeWitt Co. Sheriff, Clinton PD & Farer City PD paying now with the fee based off Population. Adding City Of Maroa into the that would mean that Maroa would make up 10% with a cost of over \$55000.00, but County Manager stated they would be interested in talking about that fee if the City Of Maroa wanted to counter offer.

Chief also looked into New Portable Radio's and Vehicle Repeaters needed to work with DeWitt County System. Global Technical System, Inc. sales Kenwood System with Portable costing \$3225.00 each (5-6 Needed) and Vehicle Repeater cost \$4493.20 each (2-3 Needed).

The cost to switch would be very high at this time, compared to the \$26410.27 fee thru CIRDC.
