**ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE CITY OF MAROA
FOR THE CITY OF MAROA FOR THE FISCAL YEAR COMMENCING MAY 1, 2018 AND
ENDING APRIL 30, 2019**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAROA AS FOLLOWS:

SECTION 1: That the total amount of appropriations for all corporate purposes legally made to be collected from the tax levy of the current fiscal year commencing May 1, 2018, and ending April 30, 2019, is hereby ascertained to be the sum of the total amount of Two Hundred Eighty-Six Thousand Four Hundred Twenty-Three Dollars and No Cents (**\$286,423.00**).

SECTION 2: That a Budget and Appropriation Ordinance was duly passed and the amounts duly appropriated.

SECTION 3: That the total amount of Two Hundred Eighty-Six Thousand Four Hundred Twenty-Three Dollars and No Cents (**\$286,423.00**), being the total appropriations heretofore legally made which are to be collected from the tax levy of the current fiscal year of the City of Maroa, for all corporate purposes of said City of Maroa, for purposes of providing for an Administrative/Corporate Expense Fund, Police Protection Fund, Social Security Benefits and Illinois Municipal Retirement Fund Benefits, Waterworks Operation and Maintenance Fund, Street Lighting Fund, Insurance and Tort Liability Fund and Audit Fund, Sewage Fund, and Medicare Fund, as appropriated for the current fiscal year be, and the same is hereby levied upon all of the taxable property of the City of Maroa subject to taxation for the current year, the specific amounts levied for the various funds heretofore named being included herein by being placed in separate columns under the heading "Levy" which appears over the same, the tax so levied being for the current fiscal year of said City of Maroa, and for the said appropriation to be collected from said tax levy, the total of which has been ascertained as aforesaid and being as follows:

SECTION 4: That the total amount of Two Hundred Eighty-Six Thousand Four Hundred Twenty-Three Dollars and No Cents (**\$286,423.00**) ascertained as aforesaid be, and the same hereby, levied and assessed on all property subject to taxation within the City of Maroa according to the value of said property as the same is assessed and equalized for State and County purposes for the current year.

SECTION 5: That the City Clerk is hereby directed to file a certified copy of this Ordinance with the County Clerk of Macon County within the time specified by law.

SECTION 6: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.




TRUTH IN TAXATION
