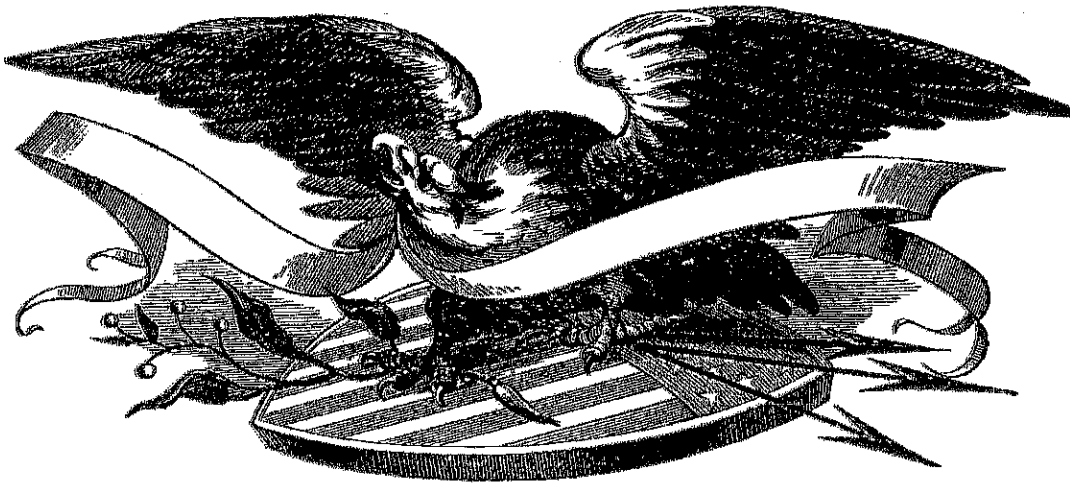

AN ORDINANCE AMENDING THE REVISED CODE OF ORDINANCES OF THE CITY OF MAROA, MACON COUNTY, ILLINOIS SPECIFICALLY CHAPTER 24 ARTICLE 9 SECTION 12 GOLF CARTS.

WHEREAS the City of Maroa has determined that it is in the interest of the public health, safety and welfare to modify its Ordinances dealing with golf carts:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Maroa, Macon County, Illinois, as follows:

SECTION 1. The Revised Code is amended as follows with language being added to the Code, if any, shown underlined, language being removed from the Code, if any, being stricken through and/or being repealed by reference to a chapter, article or section and language remaining unchanged in the Code, if any, being neither underlined nor stricken through and language contained in brackets [], if any, being explanatory notes, which may effect the interpretation of the language of the Code, but language in brackets, itself, not being added to the Code:

24-9-12 No Golf Cart may be operated in the City of Maroa unless it displays a current Permit. Permits are issued annually and extend from April 1 until March 31 of the next succeeding year. The yearly cost of the permit shall be Twenty Five Dollars (\$25.00).

24-9-13 Permits shall be displayed on the rear of the Golf Cart as close to the center of the Golf Cart as possible and shall remain visible at all times.

24-9-14 Prior to begin issued a permit, each Golf Cart shall undergo an inspection by an Officer of the Maroa Police Department. The Golf Cart must pass inspection and must meet each and every item on the inspection checklist prior to being issued a permit.

24-9-15 The owner of the Golf Cart will be deemed to be the owner listed on the Golf Cart Registration. It shall be a violation of this ordinance, chargeable to the owner of the Golf Cart, if the Golf Cart is operated by any person not otherwise allowed to operate a Golf Cart under this ordinance.

24-9-16 Owner's and operators of Golf Carts in the City of Maroa are charged with the responsibility of being fully aware, knowledgeable of and adherence to the regulations, rules and requirements of this ordinance and all applicable law of the State of Illinois.


