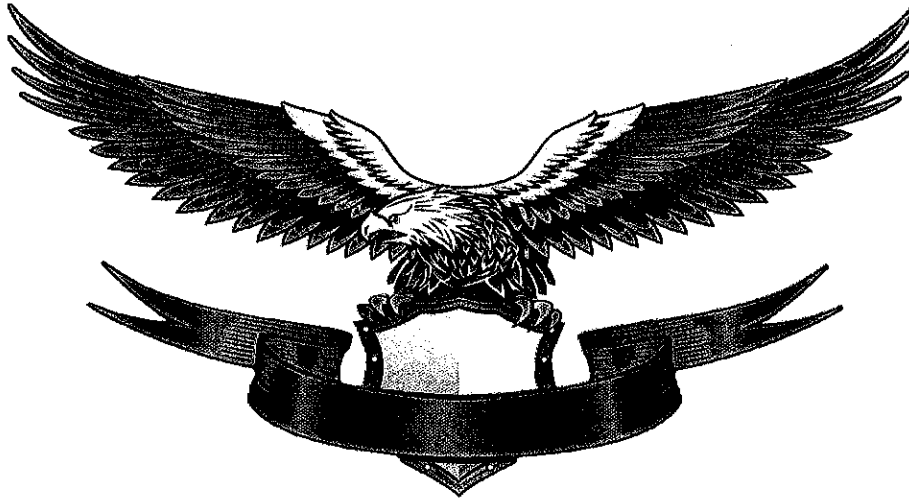

**AN ORDINANCE AMENDING THE REVISED CODE OF ORDINANCES OF
THE CITY OF MAROA, MACON COUNTY, ILLINOIS, SPECIFICALLY
CHAPTER 7, ARTICLE 4, DIVISION 5.**

WHEREAS, the City of Maroa, Macon County, Illinois has determined that it is in the best interest of public health and safety to modify its ordinances dealing with coin-operated amusement devices and video gaming:

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MAROA, MACON COUNTY, ILLINOIS, as follows:

SECTION I: The Revised Code, Chapter 7, Article 4, Division 5 is hereby amended by deleting the language “Ten Dollars (\$10.00) per year or part thereof for each coin-operated amusement device” and in its place the following language shall be substituted: “an annual fee for such license shall be Three Hundred Dollars (\$300) per year for all coin-operated amusement devices”.


SECTION II: The remaining provisions of Chapter 7, Article 4, Division 5, shall remain unchanged and in full force and effect,

SECTION III: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.


